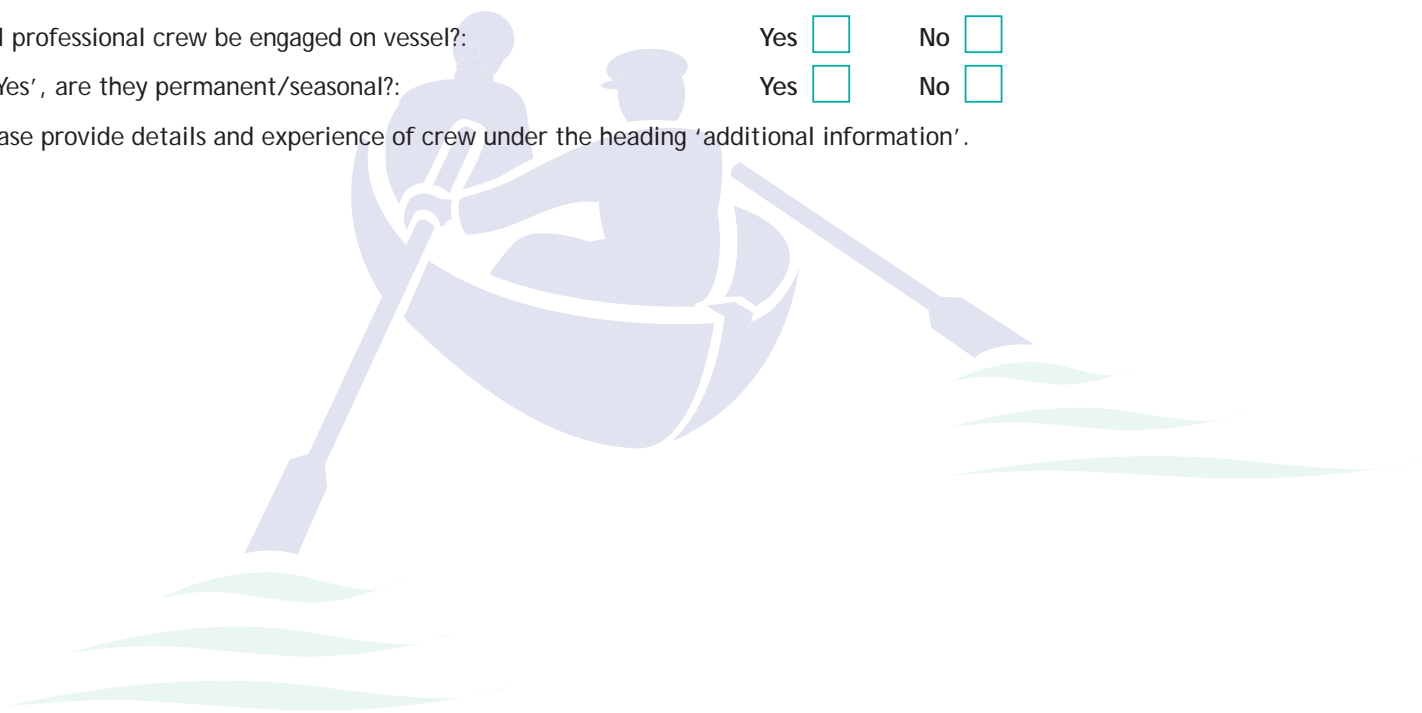

### Note 1:
